Notice of Intent

The Administrator of the Division of Environmental Protection gives notice that an application for a Reclamation Permit for an Exploration Project for the Moonlight Exploration Project has been properly filed with the Division of Environmental Protection in Carson City. The applicant for Reclamation Permit # 0286 is:

TGC Holdings Ltd.

This project, will be located within Pershing County, and is in Sections 1, 2, 10, 11, 12, 13, 14, 15, 16, 22, 23, 24, and 27 of Township 29 N, Range 34 E; and Sections 6, 7, 18, 19, and 30 of Township 29 N, Range 35 E, M.D.B. & M., Pershing County, Nevada, approximately thirty miles northeast from the community of Lovelock, Nevada. The exploration project consists of 8.35 acres of previously-authorized disturbance on public land and 4.53 acres of proposed disturbance on private land. Proposed reclamation activities include plugging drill holes, re-grading and seeding disturbed areas to their approximate original contour.

The Administrator is constrained to issue the reclamation permit or to deny the application. The Administrator has made the tentative decision to issue the reclamation permit.

Persons wishing to submit written comments or information on the tentative decision must do so in writing no later than by 5 pm on September 22, 2008. Any person who is directly affected by the application for a permit may request, in writing, a public hearing on the application for a permit. The request must state the reason for the request and the issues to be raised at the hearing. This request must be submitted, in writing, no later than by 5 pm on September 22, 2008.

All comments or objections received during the public notice period will be considered in the final determination regarding this application. If the Division determines written comments or requests are reasonable and indicate a significant degree of public interest in this matter, the Administrator shall schedule a public hearing in accordance with the requirements of NAC 519A.200. The Division will accept written comments in the form of facsimile, e-mail, or by mail. The comments may also be hand delivered.
