Enclosed for "re-drafting" by the LCB Legal Division is a proposed permanent regulation that would amend NAC 445B. This regulation will add a requirement for certain electric generating units to install best available retrofit technology and comply with emission limitations for NOx, SO2 and PM10.

Special Note: There is only one change being requested to this regulation. Somewhere between the workshop version and the SEC adopted version a cell in a table was dropped. This error needs to be corrected. The correction occurs in paragraph (b) of subsection 1 of section 4 of R190-08 and is shown in the attached revised regulation. Under the "Control Type" column for NOx there should be three cells, one for each unit. The top two cells read, "Low NOx burners with flue gas recirculation;" the third cell should read, "Low NOx burners with selective non-catalytic reduction."
