This regulation amends Chapter 486A of the Nevada Administrative Code (NAC) to reflect recent changes made in statute by the Nevada Legislature (i.e., S.B.332). The proposed changes clarify in regulation both the types of alternative fuels and vehicles that will comply with the Alternative Fuels in Fleets program. The regulation addresses vehicle acquisition and fuel use requirements, reporting requirements, and program applicability. Overall the proposed regulation will provide more flexibility to respond to changes in the alternative fuels and low emission vehicles markets.
