RE: R015-11: Air Pollution Control Adopt by Reference; Greenhouse Gas Permitting

Dear Ms. Corp:

Attached is a permanent regulation referenced above that was adopted by the State Environmental Commission (SEC) on October 5th 2011. Also attached is the filing statement required by NRS 233B.066 and the SEC form for filing administrative regulations with the Secretary of State.

The regulation updates Nevada's adoption of the federal "prevention of significant deterioration of air quality" (PSD) rule to include US EPA's greenhouse gas (GHG) permitting requirements. This proposed permanent regulation was adopted as a temporary regulation (T009-11) by the SEC on the June 16, 2011. Without adoption as a permanent regulation, US EPA would be the primary PSD permitting authority for sources in Nevada.
