Attached is a permanent regulation referenced above that was adopted by the State Environmental Commission (SEC) on October 5th 2011. Also attached is the filing statement required by NRS 233B.066 and the SEC form for filing administrative regulations with the Secretary of State.

This regulation deletes NAC 444.8675. The regulation did require biennial reporting of hazardous waste; however this reporting is more stringent than federal requirements. While federal regulations require only large quantity generators to submit biennial reports, State regulations require any generator holding an active USEPA identification number to report. Accordingly, by deleting this reporting requirement State regulations would be consistent with federal requirements and thereby reduce the regulatory burden on businesses generating small quantities of hazardous waste in Nevada.
