Attached is a permanent regulation referenced above that was adopted by the State Environmental Commission (SEC) on October 5th 2011. Also attached is the filing statement required by NRS 233B.066 and the SEC form for filing administrative regulations with the Secretary of State.

As way of background, NRS 445B.760 establishes the authority of the SEC to prescribe standards for emissions from mobile internal combustion engines. The authority under this section includes the authority to provide for the exemption from such standards of a vehicle for which special license plates have been issued to certain older motor vehicles. Accordingly, this regulation amends NAC 445B.6115 to exempt vehicles that have been issued special license plates from emissions testing requirements. This change is being proposed pursuant to the passage of AB2 by the 2011 Nevada Legislature.
